<u>Issue 3</u>: What is the total purchased gas adjustment true-up amount to be

refunded in the January, 2008 through December, 2008 period?

FPU's Position:

\$3,717,419 (overrecovery)

<u>Issue 4</u>: What is the appropriate levelized purchased gas cost recovery (cap)

factor to be charged during the period January, 2008 through December,

2008?

FPU's Position:

150.001 cents per therm.

Issue 5: What should be the effective date of the new purchased gas adjustment

charge for billing purposes?

FPU's Position: The factor should be effective for all meter readings on or after

January, 2008, beginning with the first or applicable billing cycle for

the period January, 2008 through December, 2008.
