1. On September 26, 2007, AT&T Florida filed its Response to dPi's Request for Information, Number 1-19, as required by the ruling on dPi's Motion to Compel, which is included in the Pre-Hearing Order issued in this proceeding. AT&T Florida filed a Notice of Intent to Request Specified Confidential Classification regarding this proprietary material on that same day.

2. AT&T Florida hereby files this Request for Specified Confidential Classification because the information contained in this response includes customer specific information that is confidential and proprietary under Florida Statutes, Sections 364.183 and 364.24.

7. The original of this Request was filed today with the Division of the Commission Clerk and Administrative Services and a copy was served on the Parties.


