Actually, Deltacom recently marked-up the form of the 3-year extension amendment and sent it back to AT&T, through our AT&T Interconnection Agreement Manager, for review. Essentially, we pared unrelated language and issues from the proposed amendment. AT&T is correct in that if the parties successfully negotiate the amendment, we will seek to withdraw the Florida arbitration petition. Until that amendment is executed by both parties, however, we will not be withdrawing the arbitration petition and believe this docket should remain open.
