**SUMMARY NOTICE OF PROPOSED CLASS ACTION SETTLEMENT**  
**AND SETTLEMENT HEARING**

**IF YOU WERE A CUSTOMER OF POWERNET GLOBAL COMMUNICATIONS ("PNG") BETWEEN APRIL 2003  
AND JULY 2006, YOU COULD RECEIVE COMPENSATION FROM A CLASS ACTION SETTLEMENT**

The purpose of this Notice is to inform you of a proposed settlement of a class action lawsuit *UCAN/Maycumber v. PowerNet Global Communications, et al.*, Case No. 06-CV-1773-H (RBB) (the "Action"), pending before the United States District Court for the Southern District of California (the "Court"). This Notice is also to inform you of a hearing to be held by the Court to consider the fairness, reasonableness, and adequacy of the proposed settlement. The hearing to consider whether the proposed settlement should be approved (the "Fairness Hearing") will be held on November 19, 2007, at 10:30 a.m. in Courtroom 13 of the Court, located at 940 Front Street, Fifth Floor, San Diego, California 92101. The full details of this settlement are contained in a Stipulation of Settlement dated as of July 26, 2007 that has been filed with the Court, as well as in a Notice of Proposed Class Action Settlement and Settlement Hearing ("Class Notice"). Copies of these documents can be obtained by downloading the documents at [www.powernetsettlement.com](http://www.powernetsettlement.com).

**Options Regarding Settlement**

1. If you decide to participate in the settlement, you need to do nothing *other than* submit a claim form electronically at [www.powernetsettlement.com](http://www.powernetsettlement.com), or by mailing it to: "PNG Class Settlement, c/o Gilardi & Co. LLC, P. O. Box 8060, San Rafael, CA, 94912-8060". You also can submit a claim form electronically from the above website. You also can get information about the settlement or order a copy of the claim form by calling 1-800-831-7159. The deadline to submit the claim form is **December 17, 2007**.
2. If you wish to object to the proposed settlement, you must file your written objections by **no later than November 5, 2007**, with the Court Clerk, located at 880 Front Street, Room 4290, San Diego, California 92101 and mail them to counsel for plaintiffs and defendants. You must also include the case name and number, your name, address, PNG telephone number and signature. See the Class Notice for more details.
3. You may request to be excluded from the settlement. If you want to request exclusion, you must do so in writing by stating you are requesting exclusion and listing your name, address, PNG telephone number and signature, and sending this exclusion request to PNG Class Settlement c/o the Claims Administrator at the above address. To be valid, requests for exclusion must be **postmarked by no later than November 5, 2007**. See the Class Notice for more details.
