

Level 3 Communications, LLC ("Level 3"), by and through its undersigned counsel, respectfully requests the Prehearing Officer to enter and order expanding the page limit for Supplemental Briefs from five (5) pages to seven (7) pages, excluding attachments. In support of this Motion, Level 3 states as follows:

1. On September 21, 2007, in Order No. PSC-07-0772-PCO-TP (the "Order"), the Prehearing Officer granted parties the opportunity to file supplemental legal briefs addressing Issues 1-3(a) as set forth in Attachment A of Order No. PSC-07-0392-PCO-TX, issued May 3, 2007, in Docket No. 070127-TX. The supplemental legal briefs were limited to five (5) pages, excluding attachments. Order, pgs. 1-2. Level 3 requests an additional two pages for the supplemental legal briefs to help ensure that the parties have the opportunity to adequately and succinctly address the pending legal issues in this proceeding.

2. Counsel for Level 3 has discussed this motion with counsel for Neutral Tandem and has been authorized to represent that Neutral Tandem does not object to the granting of this motion.




