Dear Sir or Madam:

United Systems Access, Inc. ("USAI"), American Fiber Network, Inc. ("AFN") and CloseCall America, Inc. ("CloseCall") (collectively, the "Parties"), transmit an original and fifteen (15) copies of this filing to notify the Commission of a transaction which will result in a transfer of control of AFN and CloseCall to USAI. USAI has entered into an agreement with AFN and CloseCall's parent, MobilePro Corp. ("MobilePro"), through which USAI will acquire 100 percent of the stock of AFN and CloseCall. As a result, AFN and CloseCall will become wholly-owned subsidiaries of USAI.

The transaction has been structured such that it will be transparent to AFN and CloseCall's customers in Florida. Following the closing, both AFN and CloseCall will continue as going concerns. The transaction will not affect the rates, terms or conditions under which AFN and CloseCall provide service in Florida. The transaction also will not affect the names under which AFN and CloseCall provide service in Florida, and will not cause disruption to the services received by AFN and CloseCall customers in Florida.

Although the transaction will not change the services provided to AFN and CloseCall's customers, the Parties expect that the transaction will improve their business operations. Specifically, AFN and CloseCall will benefit from the highly qualified and

experienced management and financial resources provided by USAI. Indeed, as described below, USAI, through one of its subsidiaries, currently holds authority to provide telecommunications services in several states. As a result, the Parties submit that the transaction will provide AFN and CloseCall access to significant additional resources which will benefit its customers.

It is the Parties' understanding that Commission approval is not required to complete the transaction described herein. Accordingly, the Parties submit this letter for informational purposes only to ensure the continuing accuracy of the Commission's records. The Parties further state as follows:

**I. DESCRIPTION OF THE PARTIES**

**A. United Systems Access, Inc.**

USAI is a privately held Delaware corporation with offices located at 5 Bragdon Lane, Suite 200, Kennebunk, Maine 04043. USAI's subsidiary, United Systems Access Telecom, Inc. ("USATI"), is authorized to provide competitive local and/or long distance telecommunications services in Delaware, Maine, Maryland, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont.

**B. American Fiber Network, Inc.**

AFN is a Delaware corporation with offices located at 9401 Indian Creek Pkwy., Suite 280, Overland Park, Kansas 66210. AFN is wholly-owned by MobilePro Corp. AFN currently provides resold and facilities-based local exchange service, resold and facilities-based long distance services, voicemail and other standard voice features, and DS1 services. In Florida, AFN is authorized to provide local and long distance services. *See* Docket No. 99180-TI, TJ333; Docket No. 991630-TX, Certification No. 7303 (April 3, 2000; January 25, 2000).

**C. CloseCall America, Inc.**

CloseCall is a Delaware corporation with offices located at 101A Log Canoe Circle, Stevensville, Maryland 21666. CloseCall is wholly-owned by MobilePro Corp. CloseCall currently provides resold local and interexchange telecommunications services.

### **III. DESCRIPTION OF TRANSACTION**

The parties shall complete a transaction through which AFN and CloseCall will become wholly-owned subsidiaries of USAI. Specifically, MobilePro and USAI have entered into an agreement dated as of June 30, 2007, whereby MobilePro, which currently owns 100% of the equity of AFN and CloseCall, will receive a combination of cash and USAI stock and AFN and CloseCall will become wholly-owned subsidiaries of USAI.

Following the transaction, AFN and CloseCall's customers will continue to receive services under the same rates, terms and conditions as those services are currently provided. The transaction will not affect the names under which AFN and CloseCall provide service. The transaction will not cause any service interruptions or have any impact on AFN and CloseCall's day-to-day operations in Florida. The Parties therefore expect that the transactions will be transparent to AFN and CloseCall customers.

### **IV. PUBLIC INTEREST CONSIDERATIONS**

The operations of the Parties are highly complementary. USAI, through USATI, offers local and/or long distance services in ten states. USAI also has experience and expertise in the provision of Internet services and technology services. Combined AFN and CloseCall maintain a substantially wider coverage area for local and long distances services, and extensive experience in providing regulated services to commercial and residential customers. The Parties believe the transaction will enhance the ability of the companies to expand their respective operations both in terms of service area coverage and offer customers more products and services. In addition, the Parties expect that the transaction will yield substantial operational and financial benefits to the combined companies.




