Dorothy,

The docket titles in Docket Nos. 070610-TX and 070611-TX need to be altered slightly. The dockets do not have the correct certificated names of the companies. Both dockets involve Tele Circuit Network Corporation (the correct certificated name), but the company listed its name incorrectly in the filing as Tele Circuit Network Corp. In Docket No. 070610-TX, "Inc." is left off of Actel Wireless, Inc.'s name, and in Docket No. 070611-TX, "Inc." is left off of Deland Actel, Inc.'s name. Finally, both dockets have a company with "Actel" in its name, but they are separate companies with no apparent ties. Even so, both docket titles refer to the companies as "Actel" in its second reference of the company. I suggest that in Docket No. 070611-TX, the second reference be changed from "Actel" to "Deland."

Therefore the docket titles should be changed as follows:
