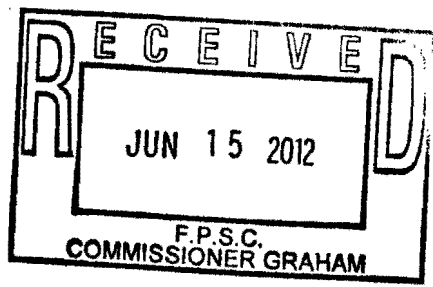

Dear Art Graham:

I am writing to you today because I am committed to increasing communication with the leaders of our state in an effort to better serve you. I recently accepted the responsibility of serving as president of Florida Power & Light Company, the third-largest electric company in the nation. FPL was founded more than 80 years ago, and when I think about the blood, sweat and tears that went into building this company and the great state of Florida, I'm humbled.

Today, the 10,000 employees of FPL are working hard to provide our customers with the lowest bill in the state, strong reliability, nationally recognized customer service and a clean energy profile among the best in the country. In addition, we are continuing to make the major investments in our electric system that will help you become more competitive and help Florida's economy prosper.

We know what makes Florida special – the sunshine, the Everglades, the fishing and more. The diversity of our state and the quality of life our families and customers enjoy are competitive advantages as is the Sunshine State's sense of optimism and opportunity, particularly as we work together to emerge from challenging economic times.

But with everything wonderful about Florida comes the threat of extreme weather. The meteorologists may be forecasting a milder than normal hurricane season this year, but as we've all heard it said: it only takes one storm to make it a bad year.

We all have to be prepared. On May 30, Florida Adjutant General Major General Emmett R. Titshaw, Jr., State Division of Emergency Management Director Bryan Koon and I joined FEMA Administrator Craig Fugate – Bryan's highly respected predecessor who led Florida's response to the 2004 and 2005 hurricanes – at the White House to brief the President about our hurricane season preparations. Representing Florida and the electric power industry in the Situation Room in front of the Commander-in-Chief was an honor and served as a reminder of the duty that FPL and our fellow electric utilities have to our customers. So, with the official start of the 2012 hurricane season upon us, I would like to share a few thoughts with you about what we're doing to prepare.

Since 2006, FPL has invested nearly \$1 billion to make our electric system more resilient to severe storms. This includes hardening the infrastructure that serves every major hospital and acute care center in our service territory. We have also developed cutting-edge technology such as the Restoration Spatial View, an advanced GPS system that helps us better direct and re-direct crews while they're in the field to restore power more efficiently in the wake of a storm.

We've improved how we deploy resources and increased the various ways of getting information to our customers. In 2011, we built our first-ever Category-5-rated Command Center. If you'd like to learn more about our efforts, go to www.youtube.com/FPL.

At FPL, we have a comprehensive plan to respond safely and as quickly as possible when our electric system is damaged by any severe weather event. Our plan focuses on readiness, restoration and recovery. And we are committed to communicating frequently through the news media and other channels so you can plan ahead.

Our resources and capabilities have evolved, but we can never forget that hurricanes and tropical storms are awesome forces of nature. Damage from storms can vary widely, and no electric system is storm-proof. But one thing is certain: when the storm passes, FPL will be working around the clock until everyone has their power back on.

If you've lived here during a hurricane, you know what can happen. But many of your colleagues, employees and neighbors may be among the tens of thousands who have moved to Florida in recent years and have never experienced the power of a hurricane. I urge you to help make preparedness a top priority for everyone you know. One easy way to help is to share the simple checklists and other basic preparation materials available for download at www.FPL.com/storm. The better we all prepare, the faster we will recover from a hurricane.

In closing, let me thank you for your commitment to our state. I'm excited about my new job and optimistic about the future of Florida. I look forward to exchanging views with you in the months and years ahead, and to working together to re-energize our state's economy and make Florida an even better place to live and to work. 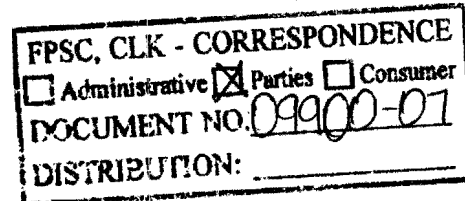

FPL REQUEST FOR RECONSIDERATION/CLARIFICATION

Reconsideration Item 1 Eliminating credit risk – The following language should be included in the order on reconsideration: **“For the purposes of this order, the phrase 'for all practical purposes and circumstances' does not include circumstances which could excuse the state from the state pledge, or acts or omissions associated with any potential bankruptcy of FPL.”** (add to Finding of Fact 81, p. 31, before the sentence: “We direct that this transaction be structured to achieve this result.”)

Reconsideration Item 2 Guaranty of Timely Payment – The following sentence from the Staff recommendation (bottom of page 7 continuing on the top of page 8 of the Staff Recommendation on Reconsideration) should be included in the order on reconsideration (would become the last sentence in the 4th ordering paragraph on page 50): **“By its plain terms, [this requirement] does not establish FPL as a guarantor of payments on the storm-recovery bonds, nor is it intended to do so.”**

Reconsideration Item 3 -- Moot

Reconsideration Item 4 Certification that each tranche of storm-recovery bonds meets the lowest cost objective - The following sentence from the Staff recommendation (page 13, in the fourth full paragraph of the Staff Recommendation on Reconsideration) should be included in the order on reconsideration (would be inserted before the sentence “Each of the standards and procedures set forth in this Financing Order must be met” in Finding of Fact 95; would become the second sentence of Finding of Fact 105; and would be the last sentence in the 4th ordering paragraph on page 57): **“By its plain language the Financing Order does not require that each tranche be reviewed solely based on interest rate achieved but also in light of upfront and ongoing costs, including marketing costs.”**

Reconsideration Item 5 Recovery of Incremental Costs – The following new language should replace the last two sentences in Findings of Fact 114b. and 116: **“FPL will have the opportunity to seek recovery of any incremental costs associated with FPL’s role as servicer or administrator of the storm-recovery bonds as part of FPL’s retail base rate proceedings.”**

Reconsideration Item 6 Allocation of partial payments - Agree with Staff’s change.

Clarification Item 1 -- Moot

Clarification Item 2 Withholding of Financial Advisor’s Certificate – The following sentence from the Staff recommendation (bottom of page 18 of the Staff Recommendation on Reconsideration) should be added to the Financing Order (would become the last sentence of Finding of Fact 135, p. 43; the last sentence of the 4th ordering paragraph on page 57 of the Order; and the last sentence of the last ordering paragraph on page 58 of the Order that continues to the top of page 59.): **“[T]he Commission has provided itself the discretion to allow the storm-recovery bonds to**

be issued in the absence of a certification from FPL, the bookrunning underwriter, or its financial advisor.”

Clarification Item 3 Application of Fees to Reserve – Agree with Staff’s change.

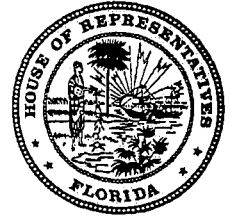



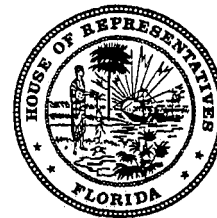
