**THE TOWN OF PALM BEACH, FLORIDA'S NOTICE OF WITHDRAWAL
 OF MOTION TO HOLD PROCEEDINGS IN ABEYANCE**

The Town of Palm Beach, Florida ("Palm Beach" or "Town"), an intervenor party in this docket, hereby withdraws its Motion to Hold Proceedings in Abeyance filed on September 6, 2006, and gives notice of that withdrawal to all parties.

In summary, the Town's Motion requested that the Commission issue an order holding further action by the Staff or the Commission in this docket in abeyance, pending the completion of a comprehensive engineering life cycle cost-effectiveness study of underground vs. overhead distribution facilities that is presently under way and that is being funded in part by the Town. Specifically, the Town of Palm Beach asked the Commission to defer any Staff recommendation or Commission action on this matter for approximately 75 days, such that it would not come before the Commission at an agenda conference before December 19, 2006. FPL responded that it did not object to the requested re-scheduling of events in this docket, subject to the Town's furnishing a copy of the subject cost-effectiveness study at an earlier date than had been contemplated by the Town. Following productive discussions between counsel for the Town and for FPL, the Town and FPL have agreed that the Town will furnish a copy

of the study, either electronically or via hand delivery to FPL's Tallahassee offices, by 12:00 Noon on Monday, November 6, 2006; that the Town will respond, subject to any proper objections, to discovery requests posed by FPL to the Town concerning the study electronically or by hand delivery to said office within 20 days of FPL's electronic service of such discovery; and that FPL will on October 20, 2006 serve its answers to the Town's second set of interrogatories answers electronically and make the documents responsive to the Town's second request for production of documents available for review in Tallahassee.

Accordingly, based on this agreement and on the Town's understanding that the matter will not be taken up at an agenda conference before December 19, 2006, the Town hereby withdraws its Motion for Abeyance and gives notice of such withdrawal to all parties. The undersigned has conferred with counsel for FPL and is authorized to represent that the foregoing accurately represents FPL's understanding of the procedural matters discussed herein.

**PSC APPROVES PLANS TO FURTHER STRENGTHEN THE

TALLAHASSEE — The Florida Public Service Commission (PSC) today approved a proposal by Florida Power & Light (FPL) intended to provide an incentive for local governments to move overhead power lines underground. FPL requested the change to its operating tariff in order to improve reliability of service and reduce vulnerability to storm damage.

"The approved tariff provides local governments with a viable new option to use as a means of strengthening their electric infrastructure," said PSC Chairman Lisa Polak Edgar. "The Commission will continue to encourage Florida's investor-owned utilities to implement strategies to minimize future storm damage and reduce the resulting outages experienced by customers."

Under FPL's previous operating tariff, the company required local governments requesting a conversion project to pay the full cost of moving overhead power lines underground. FPL's revised tariff now credits the sponsoring local government 25 percent of the total expense.

An analysis by FPL indicates the 25 percent undergrounding credit represents the average savings in storm restoration costs the utility's entire customer base would share following a major weather event.

The PSC approved the tariff as a limited time pilot project, expiring in October 2008, when more information on storm hardening is filed and additional cost/benefit reviews can be initiated. At least 60 days before the tariff expires, FPL is required to file a report with the PSC with updated information on the initial estimated storm restoration costs and provide actual figures if they are available. At that time, FPL should be prepared to petition the PSC to continue, modify, or discontinue the tariff.

**Testimony before the Florida Public Service Commission
in Docket 060150-EI
by Dr. Charles Falcone, Mayor, Town of Jupiter Island, Florida
April 24, 2007**

Good morning. My name is Charles Falcone, and I am Mayor of Jupiter Island, Florida (Town). I hold a doctorate in Electric Power Engineering from Rensselaer Polytechnic Institute, and in my professional career, I worked for more than 30 years in the electric power industry, including senior management positions with American Electric Power Company. I also served as Director of Power Supply and Reliability in the Office of Utility Systems, Economic Regulatory Administration, U.S. Department of Energy, in the late 1970's. Through my testimony today, I hope to encourage the Commission to act favorably on Florida Power and Light's (FPL's) proposal to amend its CIAC calculation in connection with underground distribution conversion, and other aspects of its "Storm Secure" Plan. I also hope to persuade you to approve the sound and beneficial Stipulation that the MUUC entered into with FPL in this docket.

Executive Summary:

1. **DO** approve the FPL-proposed 25% credit to reduce undergrounding CIACs to account for storm restoration cost savings.
2. **DO** keep the docket open to ensure that cities and towns can get credit for all the cost savings that underground conversion provides.
3. **DON'T** label FPL's "Governmental Adjustment Factor" tariff as a "pilot project" or trial, limited to a narrow time window, but approve it as a regular tariff.
4. **DO** everything you can to encourage undergrounding. Today, this includes approving the Stipulation. Ensure that towns that move forward rapidly are protected by a "relation back" provision including all credits that you ultimately approve.

It's a new and different environment that we live in today, and underground electric distribution now provides significant operational cost savings.

Years ago, it was perceived that the principal difference between overhead and underground lines was aesthetics. It could be that O&M cost differences between overhead and underground services were negligible for ratemaking purposes.

That's not true anymore, especially in a Florida setting. The predicted increased frequency of hurricanes presage long outages and large restoration costs for overhead distribution, as the sad events of 2004-05 showed; and far less restoration cost for underground service. Secondly, in this storm-threatened period coupled with a fast-growth tropical environment, utility line clearing is quite expensive, not the negligible component it once was. Underground lines eliminate all that expense. If you don't recognize and give credit for these differences and others, you will perpetuate a bad public policy that discourages underground conversion by continuing to impose unrealistic economic penalties.

We commend FPL for proposing Storm Secure. The hurricanes of the 2004 and 2005 seasons – Charley, Frances, Jeanne, Ivan, Dennis, Katrina, Rita, and Wilma - demonstrated in a profound way the great vulnerability of overhead electric power distribution systems in Florida, the great hardship caused by widespread, extended multi-day (up to 3 weeks following Hurricane Wilma) power outages, the enormous cost of restoration and the need to harden these power supply facilities. FPL recognized this need in Storm Secure, and also recognized the excellent hardening features of underground distribution conversion. **Storm Secure is a Ray of Light to many of the cities in Florida!**

The Town of Jupiter Island is a customer of FPL and would be a "Local Government Applicant" to whom FPL's proposed GAF Waiver and CIAC tariffs are applicable. Additionally, all of the Town's residents are retail customers of FPL. The Town has a direct interest in these proceedings, because after having studied and appreciated the

reliability benefits of underground conversion, it has endeavored to achieve this for several years. *However, only since FPL's announcement of Storm Secure last year have we been able to regard such an undertaking as truly feasible.*

Pilot Project: In the summer of 2006, the Town and FPL carried out a Pilot Project involving the underground conversion of about ¼ mile stretch of South Beach Road, one of the Town's main roads, in order to get a clear understanding of the feasibility, mechanics, impacts, etc. of such a project. At our request, FPL purchased and tested a new "Vista" waterproof switch, and we installed it on Jupiter Island in an underground vault as part of our Pilot Project. FPL is pleased with this switch, which resolves in large measure the concerns regarding flooding damage for underground installations in coastal areas. We consider the Pilot Program to be fully a success.

Referendum: On March 20, 2007, the Town conducted a Referendum to obtain its residents' approval for the Town Commission to undertake the borrowing of funds to pay for the Town-wide underground conversion of all its electric utility facilities. The Referendum passed with excellent resident participation and with 93% of all votes in favor. We believe that this is indicative of high citizen support for the concept of electric distribution undergrounding, not only in the Town of Jupiter Island but also in other Florida cities and towns.

In our Referendum, we made it very clear that we were asking the residents to empower the Town Commission to act on their behalf in this matter, and exercise judgment on whether to proceed with the underground conversion. In this regard, the Town Commission has closely followed your proceeding in Docket 060150 and considers it to be very important to its endeavor in several respects; and it looks to you for assurance of the following:

(a) Your approval, at a minimum, of FPL's proposed 25% cost sharing of the Town's CIAC to offset the avoided cost of service restoration following major storms. Our own studies carried out by Power Services, Inc. on behalf of MUUC, a group

of 30-some cities and towns in Florida, confirm the accuracy of FPL's calculated figure; their estimates are within a percentage point! There are clearly **other** operational cost savings associated with underground conversion, such as elimination of periodic tree and shrubbery trimming, and we ask that you approve CIAC credits associated with those savings as well.

(b) Deny the Staff's proposed 2.5 year time limit on the GAF starting April 4, 2006. This is a narrow window, and leaves only about 1.5 years from today's date. If you decide to limit the initial approval period that severely, I would ask that you state clearly that, consistent with the MUUC's stipulation with FPL, projects be allowed to proceed to completion in accordance with the tariff provisions in effect when their agreements were executed during the approval period.

(c) Provide assurance that the Town, at its option, will be permitted to employ its own (FPL-qualified) contractors to carry out all or part of the conversion work, in compliance with FPL's standards, **and still be eligible for all the credits** that you approve for FPL-executed projects, including the costs of "hardened" overhead facilities, the GAF Waiver credit for estimated storm restoration cost savings, and additional credits that you may approve in connection with implementing FPL's underground CIAC tariffs. If the Town (Applicant) chooses to do all or most of the work itself, FPL should reimburse the FPL-estimated costs for those components of the work to the Applicant, as if it were one of FPL's contractors.

(d) Assure that FPL would not be entitled to bill the Town for corporate overheads on work that the Town carries out itself. The Town will be turning ownership of the new underground facilities over to FPL, and we see no reason for the utility to further burden the Town with a share of its other corporate costs on project work that the Town undertakes itself. FPL is, of course, entitled to be paid for its engineering and design work on the project, and for its inspection of the work, on the basis of

reasonable billing rates for its staff, but not for corporate overheads on work that FPL does not do; and

(e) Assure that all credits that you ultimately approve in this docket will apply to qualified projects begun after April 2006. This should include the **GAF Waiver credit** for estimated restoration cost savings associated with tropical storms and hurricanes, any other O&M credits, and the **hardened overhead credit** (the cost of a hardened overhead distribution system, which is a credit in the CIAC calculation but will not be known until FPL's new design is submitted and approved for specific underground conversion projects). In order to encourage towns and cities to initiate underground conversion projects **now**, before your proceedings are complete, it's important to avoid penalizing them for going forward before all the regulatory steps are taken. Our Town would like to initiate conversion work this summer, but there is concern of a possible economic penalty for acting early. Project costs can readily undergo a "true up" after all of the rules are final. In simple terms, the cost-savings that underground projects provide are going to be realized as soon as the projects are complete, and it's only fair that cities and towns that proceed now get full credit, based on your-- the Florida PSC's-- ultimate decisions in this docket. Additionally, this provision for a true-up makes a lot more sense, both from a town's perspective and from FPL's perspective, than requiring us to either (i) wait until the docket is concluded or (ii) have extensive, project-specific negotiations with FPL on every job.

In light of projections for more and increasingly severe hurricanes and tropical storms in the Atlantic basin, I submit to you that the sooner we get the underground projects done, the better off everyone will be. It would be a shame if your actions or inactions today discourage towns from proceeding with their plans for conversion.

By the way, the electric utility industry has a few reports from various parts of the country, written awhile back, that say that underground distribution is no more reliable than overhead, just more expensive. I submit that these were advanced in large part by electric power companies attempting to avoid a lot of underground conversions at their

expense. If they were ever true, they certainly are not true today in Florida. Consider this--virtually all new FPL subdivisions have been using underground electric service for years, with the CIAC based on incomplete cost and benefit considerations, and with the CIAC being paid entirely by the homeowners. This tells you that **underground distribution is the state of the art**. FPL currently indicates that at least 70%, and by some estimates more than 80%, of its new subdivisions are being served by underground facilities, and FPL is further encouraging cities, towns, and counties to enact mandatory underground ordinances as part of its Storm Secure initiatives.

I respectfully ask that this testimony be included in the record of this docket. Thank you very much for your consideration.
