
MOTION TO CORRECT NOTICE OF SERVICE

1. On December 4, the Citizens propounded on K W Resort Utilities (KWRU) a Fourth Set of Interrogatories and a Fourth Request to Produce Documents. Contemporaneously, the Citizens filed their Notice of Service with the Public Service Commission. The Notice of Service was properly dated December 4, 2007, in the heading, but within the body, the Notice erroneously identifies the service date as the "4th day of November, 2007." 
