

On April 16, 2007, Utilities, Inc. of Sandalhaven (*Utility*), completed its application to the Florida Public Service Commission (*Commission*) for increased service availability charges and institution of an Allowance for Funds Prudently Invested (*AFPI*) charge.

The Commission approved temporary service availability charges of \$2,627.75, subject to refund with interest, by Order No. PSC-07-0327-PCO-SU, dated April 16, 2007.

By Proposed Agency Action (PAA) Order No. PSC-07-0865-PAA-SU, issued October 29, 2007 (*PAA Order*), the Commission approved final service availability charges of \$2,628 and the following AFPI charges:
