PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the petition of the OPC concerning the proposed adoption of Rule 25-30.4325, F.A.C., Water Treatment Plant Used and Useful Calculations, and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.
