by reference the previously provided Exhibits A through D. FPL's May 4, 2006 Request and Exhibits A through D are incorporated herein by reference.

- 3. By Order No. PSC-06-0637-CFO-EI, dated July 28, 2006, the Commission granted FPL's May 4, 2006 Request.
- 4. The period of confidential treatment granted by Order No. PSC-06-0637-CFO-EI will soon expire. All of the information that was the subject of FPL's May 4, 2006 Request warrants continued treatment as proprietary and confidential business information with the meaning of section 366.093(3).
- 5. Included herewith and made part of the hereof is Exhibit D. Exhibit D consists of the affidavit of Thomas Hartman which shall supplement the Exhibit D previously filed.
- 6. FPL submits that such information is proprietary confidential business information within the meaning of section 366.093(3). This information is protected by section 366.093(3)(e).

The material for which FPL seeks continued confidential classification is intended 8. to be and is treated by FPL as confidential and has not been disclosed. Nothing has changed since the issuance of Order No. PSC-06-0637-CFO-EI to render the information stale or public, such that continued confidential treatment would not be appropriate.

Accordingly, FPL requests that the information highlighted in Exhibit A to the 9. May 4, 2006 Request and referenced in Order No. PSC-06-0637-CFO-EI be accorded confidential classification for an additional eighteen month period.
