

AMENDMENT TO INTERCONNECTION AGREEMENT

THIS AMENDMENT TO INTERCONNECTION AGREEMENT (the "Amendment") is made, entered into, and effective this 9th day of January 2008, by and between Sprint Spectrum L.P., a Delaware limited partnership, and as agent for SprintCom, Inc., a Kansas corporation, all foregoing entities jointly d/b/a Sprint PCS, with offices at 6200 Sprint Parkway, and GTC, Inc. d/b/a GT Com. ("GT Com") with offices at 502 Cecil G. Costin, Sr. Blvd., Port St. Joe, FL 32456-1754 (collectively, the "Parties").

RECITALS:

WHEREAS, the Parties desire to amend their existing interconnection agreement that was approved by the Florida Public Utility Commission (the "Commission") in Docket No. 050882-TP, on February 17, 2006 (the "Agreement");

NOW, THEREFORE, in consideration of the provisions set forth below, it is agreed between the Parties that the Agreement shall be amended as follows.

AMENDMENTS TO AGREEMENT:


1. Replace paragraph 3.4 to read:

This Agreement is limited to GT Com end user customers' traffic for which GT Com has authority to carry. GT Com's NPA/NXX(s) are listed in the LERG under OCN 0291, 0329 and 0339. (Florida/Georgia)
