Amendment to the Agreement  
Between  
Saturn Telecommunication Services Inc. dba STS  
and  
BellSouth Telecommunications, Inc.  
d/b/a AT&T Florida  
Dated November 17, 2006

Pursuant to this Amendment, (the "Amendment"), Saturn Telecommunication Services Inc. dba STS (STS), and BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated November 17, 2006 (Agreement) to be effective thirty (30) calendar days after the date of the last signature executing the Amendment (Effective Date).

WHEREAS, AT&T and STS entered into the Agreement on November 17, 2006, and;

WHEREAS, AT&T and STS agree to modify the Agreement to incorporate state specific ordering charges.

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. Rates shown as OPERATIONS SUPPORT SYSTEMS (OSS) – "REGIONAL RATES" in Exhibit D of Attachment 1, Resale, are hereby deleted and replaced with those rates shown as OPERATIONS SUPPORT SYSTEMS (OSS) – "STATE SPECIFIC RATES" reflected in Exhibit 1 attached hereto and thereby incorporated into this Amendment.
2. Rates shown as OPERATIONS SUPPORT SYSTEMS (OSS) – "REGIONAL RATES" in Exhibit A of Attachment 2, Unbundled Network Elements, are hereby deleted and replaced with those rates shown as OPERATIONS SUPPORT SYSTEMS (OSS) – "STATE SPECIFIC RATES" reflected in Exhibit 2 attached hereto and thereby incorporated into this Amendment..
3. All of the other provisions of the Agreement, dated November 17, 2006, shall remain in full force and effect.
4. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
5. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
