

On September 14, 2006, Docket Nos. 060620-TX, 060622-TX, and 060623-TX were established to investigate CariLink International, Inc., Phone 1 Smart LLC, and EFFECTEL CORP, respectively, for their apparent violation of Section 364.183(1), F.S., Access to Company Records. By Order No. PSC-06-0955-PAA-TX, issued November 16, 2006, the Commission assessed a penalty in the amount of \$10,000 against each of the companies to be paid within fourteen calendar days after the issuance of the Consummating Order. The Commission further order that these dockets should be closed either upon the receipt of the payment of the penalties or upon the cancellation of the companies' certificates. On December 12, 2006, Consummating Order No. PSC-06-1029-CO-TX was issued making Order No. PSC-06-0955-PAA-TX final and effective.

Fourteen calendar days have elapsed since the issuance of the Consummating Order and the companies have not submitted their payments, therefore; CLEC Certificate Nos. 7909, 8384, and 8581 should be cancelled and the respective dockets should be (closed).




