Great question! I got involved in this matter in 2010.

The documents you enquire about have all been either returned to the Clerk for destruction, never created, or retained in the docket file. The documents are fully accounted for.

A full description of what happened to all these unnumbered "administrative" copies is provided below:

The matter involved 8 audits in total and 4 witnesses. I am restricting my discussion to those documents for which unnumbered copies are described in the Clerk's 2008 administrative files for Docket 080009.

You ask about 5 copies made from confidential documents -- there were actually 12 copies involved in this matter. The Division of Regulatory Compliance requested administrative authority to make 12 copies of various confidential materials. (See Document numbered 02164-08, pages 63 and 71).

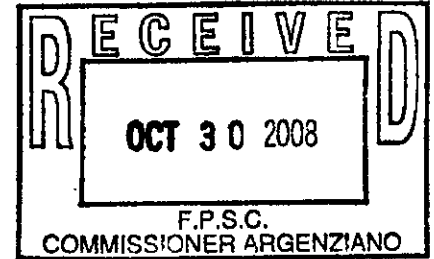

Thank you for your consideration.

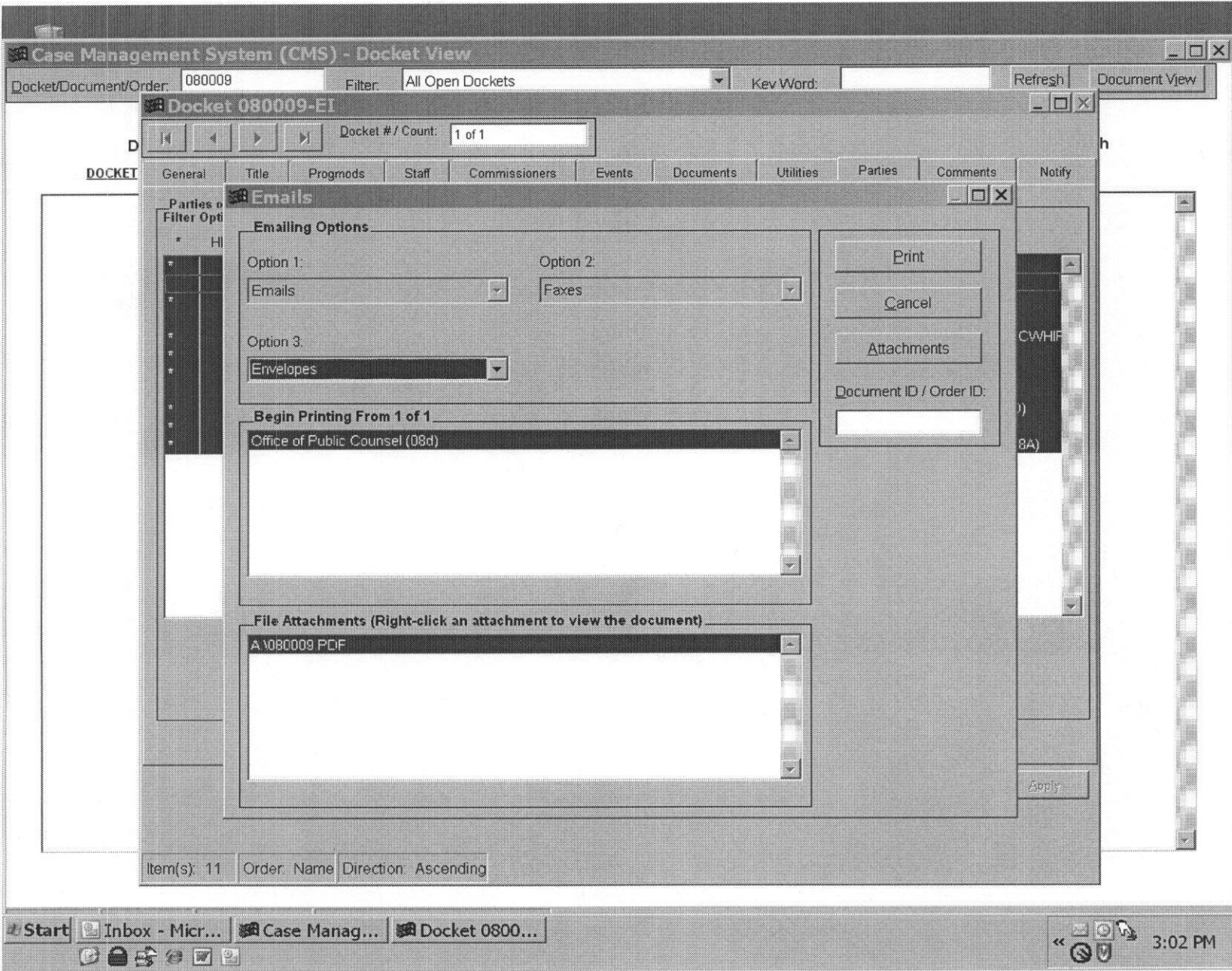

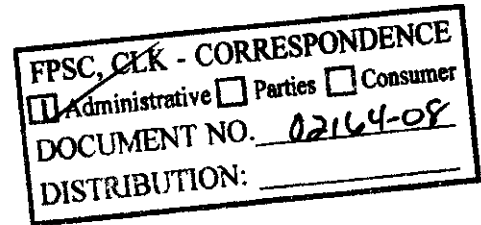
