Pursuant to Commission Rule 25-6.018(3), F.A.C., this will serve as Progress Energy Florida's quarterly report of customer interruptions and curtailments for the quarter ending March 31, 2008.

At 1:09 pm on Tuesday, February 26, 2008, an incident occurred outside the Progress Energy Florida service area that caused some PEF customers to lose power. The peak number of PEF customers without power was approximately 153,000, and their power was restored in approximately two hours. Although some Interruptible General Service (IS) and Curtailable General Service (CS) customers were affected by this event, PEF did not specifically interrupt IS or CS customers during this event.
