NEUTRAL TANDEM, INC.'S CLAIM OF CONFIDENTIALITY

Pursuant to Rule 25-22.006(5), Florida Administrative Code, and Section 364.183(1), Florida Statutes, Neutral Tandem, Inc. and Neutral Tandem-Florida, LLC (“Neutral Tandem”), by and through its undersigned attorneys, hereby submits this claim of confidentiality for certain information within Neutral Tandem’s Responses to Staff’s First Request for Production of Documents, and within Neutral Tandem’s Responses to Staff’s First Set of Interrogatories. The confidential information contained therein concerns contractual information the disclosure of which would be contrary to the parties’ agreement and would impair Neutral Tandem’s ability to compete and to contract for goods and services. This information is crucial to Neutral Tandem’s competitive interests, is treated by Neutral Tandem as proprietary, and has not otherwise been disclosed. As such, the information meets the definition of proprietary confidential business information as that term is defined in Section 364.183, Florida Statutes. 


