**ORDER TO FACILITATE THE
TRANSFER OF CUSTOMERS TO NEW
CARRIERS**

24 Upon application of the Chapter 7 Trustee, the Court is informed that the customers of the
25 above-named Debtors (collectively, "Starvox/ Capital Telecommunications") and the carriers to whom
26 such customers may seek to transfer their services seek (and require) assurances that the estates of the
27 Debtors (and their representatives) consent to such transfers, agree to facilitate such transfers, and will
28 not seek to interfere with them or impose liability on Starvox/ Capital Telecommunications' customers

1 or their chosen carriers by levying early termination charges, pursuing claims for tortious interference
2 or intentional interference with contractual relations, breach of contract or the like. The purpose of
3 this order is to give those assurances, and authorize customers and their authorized service providers
4 to take steps to transfer their services expeditiously. Therefore, good cause appearing,

5 IT IS HEREBY ORDERED that Starvox/ Capital Telecommunications' customer(s) and any
6 carrier selected by such customers to act on behalf of Starvox/ Capital Telecommunications are hereby
7 authorized to make changes requested by those customers with respect to any and all services
8 provided by Starvox/ Capital Telecommunications, including communications services, local and long
9 distance telecommunications services, information services, co-location services, and data/internet
10 services and service provider(s) (collectively "Services").

11 IT IS FURTHER ORDERED THAT said authorization includes and extends (i) to the ability
12 to coordinate with the underlying providers and/or other carriers to disconnect or change the provider
13 of Services now provided by Starvox/ Capital Telecommunications, and to otherwise assist Starvox/
14 Capital Telecommunications' customers, pursuant to their requests, in transitioning Services to other
15 service providers; (ii) to permit Service Providers to whom Starvox/ Capital Telecommunications'
16 customers desire to transfer Services (or from whom such customers desire to obtain Services) to
17 change billing addresses, change the customer of record for a service, or execute Transfer of Service
18 Agreements, all as requested by the customers; and (iii) to the ability to alter (with customer
19 permission) Primary Interexchange Carrier (PIC) designations or restrictions for those customers for
20 whom Starvox/Capital Telecommunications is the PIC.

21 IT IS FURTHER ORDERED that this authorization includes and extends (i) to the negotiation
22 of agreements between underlying providers or other carriers (or directly with requesting customers)
23 for a change in the name of the Customer of Record, a Transfer of Service Arrangement, or any
24 similar or other means of assuring the continuation of any or all Services without the need to
25 reprovision circuits or services; (ii) to Service providers to allow them to accept the requests of
26 Starvox/Capital Telecommunications' customers (and providers they authorize to act on their behalf)
27 to place orders for Service moves, adds, and/or changes (including those moves, adds, and/or changes
28 that result in the related Starvox/Capital Telecommunications circuit of the consenting customer being

1 disconnected) and to renegotiate agreements for the provision of Services (including but not limited to
2 agreements that substitute the customer itself or its chosen Service Provider, as applicable, for
3 Starvox/ Capital Telecommunications as the customer of record); and (iii) to authorize the debtor or
4 Trustee to release of a copy of customer records, including billing records, upon the customer's
5 request.

6 IT IS FURTHER ORDERED that to the extent any action taken by a party pursuant to this
7 Order would otherwise be deemed to be a violation of the automatic stay, the automatic stay will be
8 deemed to be lifted as to such action, and to the extent any such action would be deemed to be in
9 breach of an agreement with Starvox/Capital Telecommunications, such action will be deemed to be
10 authorized by Starvox/Capital Telecommunications and any respective agreement provision waived
11 accordingly.
