On February 21, 2008, Thrifty Call, Inc. filed a Notice of Intent to Request Specified Confidential Classification of its responses in Docket No. 000475-TP to AT&T Florida's Second Set of Production of Documents (PODs) Numbers 20 and 21. The filing also indicated the documents were responsive to PODs 16 and 17.

On March 17, 2008, Thrifty Call, Inc. filed its Request for Specified Confidential Classification for only the electronically stored customer information of originating and terminating numbers for POD 20. Staff agrees that the customer call detail records should remain confidential as provided in Order No. PSC-07-0679-CFO-TP issued on August 21, 2007, and Order No. PSC-07-0993-PCO-TP issued December 11, 2007.

Therefore, technical staff requests that an order be issued to extend the confidentiality of only the consumer specific information of the originating and terminating numbers on the CDs filed in Document No. 01408-08 and Document No. 08538-04.
