Sprint Communications Company Limited Partnership ("Sprint") hereby files its REVISED response to Staff's 2008 Local Competition Data Request, and requests confidential classification for certain portions thereof pursuant to Section 364.183(1), Florida Statutes.

Pursuant to Rule 25-22.006(5), F.A.C., enclosed please find two copies of Sprint's REVISED public version of Table 1 and a sealed envelope marked "CONFIDENTIAL" which contains one copy of Sprint's REVISED confidential Table 1 as well as a confidential CD with a corresponding confidential file. As required by Rule 25-22.006(5), Florida Administrative Code, confidential information in the paper documents has been highlighted, while such information has been redacted from the public responses.
