RE:	Request for Permission from Department of Financial Services to Write-Off the Penalty Imposed on Virtual Reach Corporation in Docket No. 070560-TI		

On August 10, 2007, Docket No. 070560-TI was opened to address Virtual Reach Corporation's (Virtual Reach) failure to comply with Rules 25-24.470 and 25-22.032(6)(b), Florida Administrative Code, (F.A.C.). On October 8, 2007, the Commission issued Order No. PSC-07-0808-PAA-TI, a proposed agency action order requiring Virtual Reach to pay \$10,000 per violation, for a total of \$40,000, for apparent violations of Rule 25-22.032(6)(b), F.A.C., and a penalty of \$25,000 for the apparent violation of Rule 25-24.470, F.A.C., for a total of \$65,000 in penalties. On October 29, 2007 the company protested this proposed agency action, but failed to provide any contact information. Thereafter, the company also failed to contact our staff and to respond to staff's repeated inquires.

By Order No. PSC-08-0227-FOF-TI, issued April 7, 2008, the Commission dismissed the protest with prejudice and ordered that the proposed agency action be reinstated and consummated as a final order. The Commission further ordered that, upon nonpayment of the penalty, within 14 calendar days of the order's date of issuance, the penalty be referred to the Department of Financial Services for collection. The Order Dismissing Protest and Consummating PAA Order No. PSC-07-0808-PAA-TI, was issued April 7, 2008, and payment of the penalty was due April 21, 2008. To date, the Commission has not received Virtual Reach's payment of the penalties totaling \$65,000.

CMP _____ Accordingly, staff requests that the Division of Administrative Services, Fiscal Services COM ______ Section, take the appropriate steps to refer the \$65,000 in penalties to the Department of Financial Services.
