**AMENDMENT NO. 1
TO THE MASTER RESALE AGREEMENT FOR THE STATE OF FLORIDA
BETWEEN
EMBARQ FLORIDA, INC. AND ERNEST COMMUNICATIONS, INC.**

Amendment No. 1 made this 12th day of May, 2008, is entered into by and between Ernest Communications, Inc. ("CLEC") and Embarq Florida, Inc. ("Embarq"). Embarq and CLEC are collectively referred herein as the "Parties".

BACKGROUND:

WHEREAS, the Parties entered into a Master Resale Agreement for the state of Florida ("Agreement") on November 20, 2007.

WHEREAS, the Parties wish to amend the Agreement to remove a clause from the agreement:

In consideration of the promises and agreements contained in this Amendment, the Parties hereby agree as follows:

AMENDMENT:

1. The following Section 36.1.1 from the November 20, 2007 Master Resale Agreement is deleted from the agreement:

Voluntary Federal and State Subscriber Financial Assistance Programs. Subsidized local Telecommunications Services are provided to low-income subscribers pursuant to requirements established by the appropriate state regulatory body, and include programs such as Voluntary Federal Subscriber Financial Assistance Program and Link-Up America. Voluntary Federal and State Subscriber Financial Assistance Programs are not Telecommunications Services that are available for resale under this Agreement.

2. Except as modified herein, the terms and conditions of the Parties Agreement shall continue in full force and effect. In the event of a conflict between the rates for the


DS1 and DS3 Dedicated Interoffice Transport in the Agreement and this Amendment, this Amendment shall control.

3. This Amendment No. 1 is executed by authorized representatives of Embarq and CLEC is made a part of and incorporates the terms and conditions of the Agreement.

IN WITNESS WHEREOF, Embarq and CLEC has caused this Amendment No. 1 to be executed by its duly authorized representatives.


