**Re: Withdrawal of Verizon's<sup>1</sup> § 63.71 Application to Discontinue Aviation Radiotelephone Service**

Dear Ms. Dortch:

Verizon hereby withdraws its § 63.71 Application to discontinue its Aviation Radiotelephone Service. Verizon filed its Application to discontinue this service on May 5, 2008. Verizon's Application provided notice to the Commission that Verizon intends to discontinue offering this service on July 1, 2008. As indicated in Verizon's Application, currently there are no customers for this service.

Aviation Radiotelephone Service satisfies the definition of a commercial mobile radio service (CMRS). *See* 47 U.S.C. §§ 153 (27) and 332 (d). Accordingly, Verizon is a CMRS provider with respect to this service. Pursuant to 47 C.F.R. 20.15(b)(3), CMRS providers are not required to submit an application to discontinue services. Accordingly, Verizon is withdrawing its § 63.71 Application to discontinue Aviation Radiotelephone Service. The proposed discontinuance date remains the same.
