You are correct about the Commission retaining jurisdiction over Certificates 599-W, 514-S held by Lake Suzy Utilities, Inc. (WS798); and Certificates 613-W, 543-S held by Town and Country Utilities Company (SU904 and WU811) because these utilities transverse county boundaries and they will remain active.
