6	Q.	Please state your name and business address.
7	A.	My name is Stan F. Szczygiel. My business address is 762 West Lancaster
8		Avenue, Bryn Mawr, PA 19010-3489.
9	Q.	Are you the same Stan F. Szczygiel that filed Direct Testimony on May 22,
10		2008 in Docket No. 080121-WS?
11	A.	Yes.
12	Q.	For what purpose are you filing this testimony?
13	A.	To assist the Florida Public Service Commission ("Commission") and the parties
14		in better understanding the rate case filed by Aqua Utilities Florida, Inc. ("AUF"),
15		particularly as it relates to AUF's affiliate, Lake Suzy Utility, Inc. ("Lake Suzy").
16	Q.	Can you please describe Lake Suzy?
17	A.	Yes. Lake Suzy is a water and wastewater utility providing service to water
18		customers and wastewater customers in DeSoto and Charlotte Counties, and is
19		subject to Commission jurisdiction. Lake Suzy is providing such services in
20		Florida under the name Aqua Utilities Florida, Inc., pursuant to Commission
21		approval.
22	Q.	Is a rate increase request for Lake Suzy included in the rate case application
23		filed in Docket No. 080121?

- 1 Yes. Lake Suzy is included in the above referenced rate filing. However, it
- 2 should be clarified that Lake Suzy is currently undergoing a reorganization
- because it was technically a part of Aqua Utilities, Inc. ("AUI"), and not AUF.
- 4 Q. Please explain why Lake Suzy was not part of the reorganization to
- 5 consolidate all of AUI's Commission-regulated water and wastewater assets
- 6 in Florida under AUF in Docket No. 060643?
- 7 A. By Order No. PSC-06-0973-FOF-WS, issued November 22, 2006 in Docket No.
- 8 060643-WS, the Commission acknowledged the corporate reorganization and
- 9 change in name involving AUF and other Commission-regulated AUI
- subsidiaries. In so doing, the Commission noted that the purpose of the
- reorganization was to consolidate all of AUI's Commission-regulated utility
- systems under the ownership and name of AUF, a Florida corporation. At the
- time of the Commission's acknowledgement of the reorganization it was believed
- that Lake Suzy would be conveyed to DeSoto County and would cease to be
- regulated by the Commission. For that reason, Lake Suzy was not included in the
- 16 reorganization at that time.
- 17 Q. Was Lake Suzy later conveyed to DeSoto County?
- 18 A. No. DeSoto County and Lake Suzy were not able to come to terms on a final
- 19 utility conveyance agreement.
- 20 Q. Please discuss the Company's plans going forward?
- 21 A. As explained earlier, the transfer of Lake Suzy to DeSoto County was never
- 22 consummated and Lake Suzy's water and wastewater certificates remain active.
- Accordingly, in order to ensure that all of AUI's Commission-regulated water and

- 1 wastewater systems in Florida are under AUF and to conform with the
- 2 reorganization approved in Docket No. 060643-WS, the company has taken steps
- 3 to formally merge Lake Suzy into AUF with AUF as the surviving corporation.
- 4 Q. Will the merger of Lake Suzy into AUF have any material affect on the rate
- 5 case filed by AUF?
- 6 A. No, it will not. As I stated earlier, a rate increase for the Lake Suzy system was
- 7 specifically included in the rate case application that AUF filed in this docket.
- 8 Q. Does this conclude your testimony?
- 9 A. Yes, it does.
