The purpose of this correspondence is to notify you that it appears that Integrated Services, Inc.'s (ISI's) corporate registration with the Florida Department of State, Division of Corporations, was converted to ISI's alternate name choice, Integrated Services of Nevada, Inc. Rule No. 25-24.470, Florida Administrative Code, incorporates Form PSC/CMP 31 (08/05), IXC Registration Form. As required by Form PSC/CMP 31 (08/05), an applicant must provide proof of authority to operate in Florida by providing its registration number with the Florida Department of State (DOS). During the registration process, the Commission verifies that an applicant is actively registered with DOS. As long as ISI retains an intrastate interexchange company (IXC) registration to provide IXC telecommunications services in Florida, it should

actively maintain its DOS registration. Likewise, it should request a name change from the Commission whenever necessary to ensure its certificated name matches its corporate registration in Florida. Therefore, ISI should submit a request to change its company name from "Integrated Services, Inc." to "Integrated Services of Nevada, Inc" to the Commission at the following address:
