
**NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida, Inc. ("PEF" or the "Company"), pursuant to Section 366.093, Fla. Stat., and Rule 25-22.006, F.A.C., files this notice of intent to request confidential classification of portions of the responsive supplemental documents to OPC's Second Request for Production of documents, specifically documents responsive to Request 54. These responses contain sensitive, confidential business information that third parties consider to be confidential, that if disclosed would result in PEF violating contracts with third parties and impair PEF's ability to contract on favorable terms in the future.

A separate, sealed envelope containing one copy of the confidential with appropriate lines containing confidential information highlighted is attached as Exhibit A. **This information should be accorded confidential treatment pending the filing of PEF's second request for confidential classification and a decision on PEF's request by the Florida Public Service Commission.**

Pursuant to Rule 25-22.006(3)(a)(1), PEF will file its Request for Confidential Classification for such confidential information contained therein within twenty-one (21) days of filing this notice of intent.
