

Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, hereby requests confidential classification of certain highlighted information contained in Schedule A12, Page 1 of 1 (Bates stamp page 226) for the period January 2007 – December 2007, marked "Revised June 27, 2008." In support thereof, the company says:

1. On March 3, 2008 Tampa Electric filed its Request for Confidential Classification of Schedule A12, Page 1 of 1 (Bates stamp page 226) which was also filed on a confidential basis with the Office of Commission Clerk on that same date.

2. Subsequent to that filing Staff pointed out that certain sales information was missing from Bates stamp page 226.

3. Tampa Electric is this date filing with the Office of the Commission Clerk under a separate cover letter a single confidential version of Bates stamp page 226 marked "Revised June 27, 2008" that includes the missing sales information.

4. Tampa Electric is in need of confidential protection of revised Bates stamp page 226 for the same reasons set forth in the company's March 3, 2008 Request for Confidential Classification that accompanied the original filing. Tampa Electric adopts and incorporates

5. Tampa Electric treats the confidential information contained in revised Bates stamp page 226 as confidential and has not disclosed it publicly.

WHEREFORE, Tampa Electric respectfully requests that the yellow highlighted information confidential information contained in Schedule A12, Page 1 of 1 (Bates stamp page 226), marked "Revised June 27, 2008" be afforded confidential classification for the reasons set forth above and in the company's earlier March 3, 2008 Request for Confidential Classification.


