Affidavit


Before me, the undersigned authority, personally appeared William Broeder, who being first duly sworn, deposes and says that:

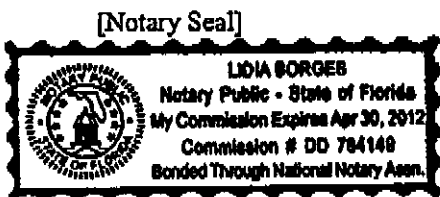


