Dear Mr. McBride:

It is staff's understanding that informal notice was given to customers of the change in ownership. However, formal notice is required to be given pursuant to Rule 25-30.030, Florida Administrative Code (F.A.C.). Until formal notice is given and the 30 day protest period has expired, your application cannot be considered filed. Staff has prepared the attached notice which must be given as described below. Note that the only information that needs to be completed on the notice is the date(s) the notice is given.

- 1. Notice to Utilities and Governments.** Pursuant to Rule 25-30.030(5) and (8), F.A.C., a copy of the notice must be given to the enclosed list of local utilities and governments and an affidavit of the noticing must be filed with the Commission. If your list includes two Department of Environmental Regulation offices or two Water Management District offices, you must identify which is the proper office for your notice. Also, the list is only valid for sixty days from its date. If you have not performed the noticing within the sixty days, you must request an updated list. The affidavit of the noticing must attach a copy of the notice and the list of entities to which it was given.
- 2. Notice to Customers.** Pursuant to Rule 25-30.030(6) and (8), F.A.C., a copy of the notice must be given by regular mail or personal service to each customer of the utility and an affidavit of the noticing must be filed with the Commission. The affidavit of the noticing must attach a copy of the notice that was given.

3. **Publication of the Notice.** Pursuant to Rule 25-30.030(7) and (8), F.A.C., a copy of the notice must be published once in a newspaper of general circulation in the area of the utility. An affidavit of the noticing must be provided by the newspaper and include the date the notice was given and a copy of the published notice.
