

BACKGROUND

Wedgefield Utilities, Inc. is a water and wastewater utility whose corporate offices are located at 200 Weathersfield Avenue, Altamonte Springs, Florida. The Utility's water and wastewater facilities are located in Orange County, Florida.

The Utility filed an application with the Florida Public Service Commission (the "Commission") for increased water rates for its Orange County customers on March 31, 2008. The application was assigned Docket No. 070694-WS, and May 30, 2008, was established as the official date of filing.

As reported in its Minimum Filing Requirements ("MFRs") filed with its application to the Commission, the Utility's revenues per books are \$746,325, with operating expenses per books of \$889,086, for its water system, resulting in a net operating loss of \$142,761 for its water system, per books, before adjustments. The rate increase application has been filed by the Utility on the basis of inadequate earnings.
