
**NOTICE OF INTENT TO REQUEST

Stat., and Rule 25-22.006, F.A.C., files this notice of intent to request confidential classification of the confidential portions of the Testimony of Carl Vinson, Robert Lynn Fisher, and Jeffrey A. Small, along with the accompanying exhibits and audit reports, filed by Staff Counsel in the above docket on August 6, 2008. This testimony contains confidential and sensitive cost figures regarding the Company's nuclear projects, including contractual cost information. Public disclosure of this information would impair PEF's competitive business interests and would also violate confidentiality agreements contained in PEF's contracts with third party vendors.

**This information should be accorded confidential treatment pending the filing of PEF's request for confidential classification and a decision on PEF's request by the Florida Public Service Commission.**


