

**JOINT MOTION OF CUTRALE CITRUS JUICES USA, INC.  
AND TAMPA ELECTRIC COMPANY TO ABATE PROCEEDING**

Cutrale Citrus Juices USA., Inc. ("Cutrale") and Tampa Electric Company ("Tampa Electric" or "the company") jointly move the Commission to hold the above-styled proceeding in abeyance pending ongoing efforts by the parties to resolve their differences by way of settlement and, in support thereof, say:

1. Cutrale and Tampa Electric are currently engaged in discussions regarding the potential for settling their differences in the above-styled proceeding.

2. Holding the above-styled proceeding in abeyance pending completion of those discussions will facilitate possible settlement, and possibly avoid unnecessary administrative litigation for the benefit of the parties to this proceeding and the Commission and its Staff. Holding the proceeding in abeyance will not prejudice the rights of either of the parties, but will permit them to focus their efforts on meaningful settlement discussions.

3. Cutrale and Tampa Electric will provide the Commission with monthly status reports on the progress of their settlement discussions.


