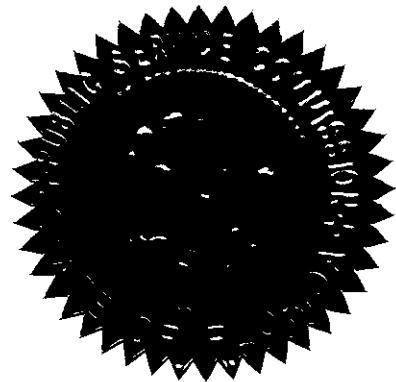

3 CHAIRMAN CARTER: Before we go to Item 3, staff has
4 an oral modification. Staff, you're recognized.

5 MR. MANN: Thank you, Mr. Chairman.

6 Staff wishes to make the following oral modification
7 to its recommendation. This is found on the recommendations
8 Page 3, the next to the last paragraph.

9 Commissioners, subsequent to the filing of staff's
10 recommendation staff became aware that Comcast's response was
11 filed on June 17 rather than June 16 as stated in the
12 recommendation. Comcast's response was thus filed untimely.

13 Staff has spoken with counsel for Verizon, and
14 Verizon has no objection to the Commission accepting for
15 consideration Comcast's response.

16 Therefore, staff recommends that the Commission
17 accept Comcast's late-filed response. If that is approved,
18 staff will incorporate the Commission's decision into the
19 order.
