**Florida Public Utilities Company
Responses to Staff Data Request
Docket No. 080072-GU**

1. Please state how many gas customers FPUC serves. Provide a breakdown between residential and commercial customers.

Company Response: As of April 30, 2008 FPUC served 52,217 gas customers; 47,307 residential and 4,917 non-residential.

2. Please provide the following information for each generator-only customer:

Attachment 1 to the Company's response to this data request includes information on service area location, actual 2007 therm consumption, average monthly consumption, current average monthly revenue and revenue under the proposed Residential Service-Standby Generator (RS-GS) rate for each generator-only customer account.

Commission Rule No. 25-7.054 (4), provides that gas utilities may require customers to pay in full for the cost of service line facilities in accordance with the Company's filed policies. The Company provides service to applicants requesting stand-by generator-only service under its approved tariff; Rules and Regulations, Section 2, "Application for Service". Paragraph 3 of Section 2 (Original Sheet No. 12) states:

"Applicants for space heating only service and stand-by only service shall be required by Company to contribute the cost of providing facilities for such service."

The Company also executes a written agreement (Second Revised Sheet No. 44) with each generator-only customer indicating the amount of the facility cost required to provide service and clearly indicating that such customer contribution is provided on a non-refundable basis. The Company does not maintain separate computerized generator-only customer service line CIAC records in its customer information or financial systems, since such contributions are not subject to refund. (The Company does maintain such records for facility extensions that are such to refund under its tariff.) The non-refundable CIAC payments are credited to a blanket service line receivable account. It would be possible, but difficult, to manually pull each customer service agreement and compile the actual CIAC collected for each customer.

Based on discussions with sales and operations personnel involved in the installation of generator-only services over the past several years, the Company is able to offer the following information.

The gas facilities covered by a customer CIAC payment for generator installations up to approximately 25 KW, include main tap, service tee, excess flow valve, an average 60 foot $\frac{3}{4}$ inch polyethylene gas service line, tracer wire, warning tape, AC250 meter, regulator, steel riser, various fittings and landscaping restoration. The current average cost for such an installation would be approximately \$750. It should be noted that the cost of such service installations has substantially increased since the Company's last rate proceeding. MFR Schedule E-7 submitted in the Company's 2004 rate proceeding indicated that the average residential $\frac{3}{4}$ inch service line, AC250 meter and regulator was installed at a cost of \$382.67. These facility costs were also used in the cost of service study approved by the Commission in Order No. PSC-04-1110-PAA-GU, to allocate Customer related costs among rate classes.

In the US market the most frequently installed residential generator is rated at 15KW. However, the vast majority of the residential generators installed on the FPUC distribution system are significantly larger than 15 KW. Many of the residential generators served by FPUC are connected to large homes (many above 10,000 square feet) with multiple air conditioning systems, elevators and other electrical equipment not found in typical residences. The FPUC gas facilities provided to serve these accounts are not typical of standard residential facilities. These installations typically require 450 cfm and greater meters, with larger service lines and regulators.

Home generator installations in the FPUC Palm Beach service area (approximately 92% of total generator-only installations) frequently exceed 50 KW and it is not unusual to see installations up to 150 KW. At these rated capacities, the FPUC standard residential service line, meter and regulator would be unable to deliver sufficient gas quantities to operate the generator. For example, a Cummins Onan RS 45000 (45KW) generator at full load would require 561 cfm; a Kohler 150RZGB (150 KW) would require 1,770 cfm at full load conditions. For these larger generator installations, the Company has been upgrading its service lines up to 1 1/4 inch when sizing up and installing meters ranging in size from 450 to 3M. These installations more closely resemble commercial facilities than residential. The cost to provide service to these installations is also similar to commercial customers. The E-7 MFR Schedule from the Company's 2004 rate case provides an average cost for non-residential service, meter and regulator installations in the FPUC GS service class of \$1,788 (2004 costs).

The point in filing the proposed RS-GS rate is not to recover the investment cost related to service line facilities; the non-refundable CIAC takes care of that issue.

Rather, the Company is not recovering its approved O&M related cost to serve and the generator-only customers are under contributing to the recovery of the cost of the gas mains and other upstream facilities utilized to deliver gas to their residence. At present, FPUC's residential Customer Charge for residential customers is \$8.00 per month (\$96.00 in annual revenue). The average generator-only annual therm consumption is approximately 29 therms, which would produce an additional \$14.00 in revenue at the current RS rate (\$0.48.34 per therm). On average a generator-only customer could be forecast to produce approximately \$110 in annual revenue. The higher fixed Customer Charge (\$18.72 per month) proposed with the RS-GS rate would at least recover FPUC's average residential cost to serve (approved by the Commission at \$224 per customer in the Company's 2004 rate proceeding).

3. Based on the following information provided in the table above, please state the total additional monthly revenues FPUC will receive from the proposed RS-GS rate.

Company Response: Based on the data provided in Attachment 1, as described above, the current average generator-only monthly base rate revenue would increase approximately \$4,125 per month under the proposed RS-GS flat rate (excluding taxes, franchise fees, conservation charges and fuel charges).

4. Please explain if and how the proposed RS-GS rate impacts the need to collect CIAC to serve generator-only customers. Will approval of the proposed rate reduce the need for FPUC to collect CIAC?

Company Response: The proposed RS-GS rate would not materially affect the Company's CIAC collections from generator-only customers. As noted in Company Response No. 2, the Company's tariff provides for the full collection of facility costs from generator-only customers.

5. What would be the impact of grandfathering the current generator-only customers on the RS rate, both on the company and the general body of rate payers?

Company Response: There are two principal concerns with grandfathering existing customers on the RS rate. First, such treatment could be discriminatory and not allowed. Leaving existing generator-only customers in the RS class and serving new generator-only customers in the proposed RS-GS class would in effect establish two rate classifications for the same service. It is not possible to differentiate service characteristics between existing and future generator-only customers. Similarly, if the existing generator only customers are transferred to the proposed RS-GS schedule at grandfathered rates, this would also present an issue of discrimination. In either instance customers would be receiving the same service but at different base rates and in the Company's view such a treatment would be discriminatory.

Second, the Company is not recovering its cost to serve the generator-only accounts. It is not unusual to find customers within a given rate class that pay more or less than the system average revenue requirement. Given that most gas rate designs continue to include substantial variable rate components, the revenue recovered from virtually all customers is heavily dependent on the customer's annual usage. Designing rates based on annual average usage generally works for most rate classes. The problem with generator-only accounts is that the probability is high that the customer will have virtually no consumption within any annual period, and may go several years without using any gas. The Company would recover only the RS Customer Charge of \$8.00 per month, significantly less than the average revenue requirement.

The investment costs in gas service facilities described in Question No. 2 above, are only a portion of the total non-fuel cost to serve that the Company should recover from generator-only customers. The Company's total cost of service includes, among other items, O&M costs, depreciation expense, taxes and a return on its investment. The allocation of such costs to customers of similar characteristics establishes a revenue requirement by rate class. Rates are designed to recover the revenue requirement based on the forecast of customers and gas usage within the class. The revenue requirement generally reflects average usage per customers in conditions of "normal" weather. As noted above, the FPUC cost of service approved by the Commission in its 2004 rate proceeding included an average cost recovery of \$224 per residential customer.

In the present circumstance, most of the generator-only customers on the FPUC system are not consuming the system average residential quantity of 266 therms per year and therefore are not contributing the system average residential customer non-fuel revenue of \$224 per year. To the extent that the generator-only customers fail to consume 266 therms per year, the Company will not generate sufficient revenues to recover its Commission approved cost to serve. Grandfathering the current residential generator-only customers would ensure that the Company continues to lose money on virtually all existing installations. The Company is not proposing to amend its base rates for traditional service (RS, GS, etc.) with this petition, therefore the grandfathering of existing generator-only customers would have no impact on the currently approved rates charged to the general body of ratepayers. Any subsidization that currently exists by the general ratepayers to make-up for revenue shortfalls from generator-only customers would continue until the Company's next rate proceeding. The additional revenue received by the Company if the proposed RS-GS rates are approved is described in Company Response No. 3.

As noted above, the cost to serve a customer with a large capacity generator (25-150 KW) is more closely aligned to commercial rather than residential service costs. Those cost differences extend beyond the gas facility investment costs described in Response No. 4. The peak gas requirements for most of the

generators installed on the Company's system far exceed those of a typical residential customer. The assignment of Capacity or Demand related costs in a cost of service analysis would further differentiate these large generators from standard residential service. In the Company's next rate proceeding it may make sense to develop generator rates that more accurately reflect such service costs, and move generator-only service into a separate class with rates based on generator capacity. In the interim, however, the proposed RS-GS class would at least enable the Company to recover its approved average residential revenue requirement for customers whose cost to serve clearly exceeds the average revenue requirement.

6. What is the approximate cost/price range for the types of individual customer generators installed on the system today? What size generators are customers installing and is their purpose to provide electricity to the whole house, or just to certain appliances?

Company Response: The Company does not maintain easily accessible individual customer records on the capacity of each generator installation. The information provided in this response is based on conversations with several operations and sales personnel involved in providing service to generators on the Company's system.

As a general rule, the cost to install a permanent (pad mounted) stand-by natural gas residential generator ranges from \$300 to \$500 per KW. The unit sizes available in the market start at approximately 7KW. According to industry sources, the most commonly installed unit across the US is 15KW. A 15KW unit would be capable of operating most household appliances including a mid-size central air-conditioner, although it may not be capable of providing electricity to the "whole house", depending on the total connected load. Most companies marketing residential generators have product lines that extend up to around 50KW. Commercial models are readily available in the 50KW to 150KW (and above) capacity range. Installed cost (not including gas facilities, but including the automatic transfer switch) for a 15KW model would be approximately \$4,500 to \$7,500. A 50KW unit would run \$15,000 to \$25,000. Generators of 100KW to 150KW capacity for extremely large residences are available in the \$30,000 to \$75,000 range, and up. It is rare that a generator-only installation below 25KW occurs in the Company's Palm Beach service area. Over 90% of the generator-only installations on the Company's system are located in its South Florida operations area. Virtually all of the generator-only installations are providing whole house service.

7. Paragraph 10 of the petition refers to propane gas equipment as an alternative to natural gas-fired generators. Please state the one-time storage tank installation fee and the monthly generator rates propane companies charge.

Company Response: Propane storage tank installation costs vary with the size of the tank and the difficulty encountered in its installation. A 30KW generator running at 50% load would consume (according to Cummins Onan) approximately 260 cf/hr of natural gas or about 3 gallons of propane per hour (72 gallons per day). A 100KW Unit could consume over 250 gallons of propane at 50% load per day. Based on the Company's experience, most residential propane generators have a minimum 500 gallon up to multiple 1,000 gallon storage tanks. It appears that most propane retailers are charging for the tank, installation and a first fill, since annual usage is not predictable. The Company's propane operation charges approximately \$2,700 for a 500 gallon tank and installation and approximately \$4,700 for a 1,000 gallon tank and installation, assuming a standard installation with 30 feet of service line. In these examples the customer would own the tank.

The generator-only propane rates offered by some companies are similar to the pool heater only rates. The generator-only rates appear to be in the \$25 to \$35 per month range, with propane delivered at a market index price plus margin. It is not unusual for a propane company to charge a tank installation fee in addition to the monthly flat rate. In this case the propane company would retain ownership of the tank. These installation fees vary widely, but can be \$500 to \$1,000 or more depending on tank size and installation requirements. The flat rate appears to be designed to recover the propane company's investment cost in the tank and the general administrative costs to serve. It is not unusual for propane companies to require a term contract of multiple years to ensure the recovery of their investment.

8. If available, please state how many customers who choose to use propane gas for the generator are assessed the tank installation fee and what costs are recovered through this fee. Does FPUC have any knowledge how many FPUC customers have opted to install propane gas equipment in lieu of connecting to the FPUC natural gas system?

Company Response: The Company does not have access to specific data related to propane industry generator-only pricing data. However, based on our experience in the market, it appears that the majority of propane fueled generator-only customers are paying for their tank and installation up front. Propane companies usually recover the cost of the storage tank, anodes, regulators, service line, other materials required for the fuel connection to the generator. In addition, the installation costs usually include burying the tank and trenching the service line. FPUC does not know how many potential customers have opted to install propane instead of natural gas.

9. Discuss on what basis a customer would choose to install a propane gas vs. a natural gas-fired generator. What are the benefits and drawbacks for each type of installation?

Company Response: The statements included in Paragraph 10 of the Company's petition were intended to indicate that there are competitive alternatives to natural gas with fixed monthly rates similar to those proposed in rate schedule RS-GS. While there is some level of competition with other fuels for generator loads, as a general rule if natural gas is available the majority of customers will choose natural gas over propane to fuel their generators. Natural gas typically provides lower up-front installation costs and lower overall operating costs for the consumer, and is reliably delivered by pipeline. If the Company must extend its main to serve the customer, the costs may be prohibitive and propane may be a lower first cost choice. There are customers who feel more secure with on-site fuel storage and may opt for propane or diesel generators. The primary reason a customer would choose propane over natural gas is the initial installation charge. If the FPUC CIAC charge is greater than the comparable propane company tank installation charge, some customers may choose propane.
