By this letter, the Commission staff requests that Florida City Gas (FCG) provide responses to the following data requests.

1. Please revise the data appearing in Table 1 of the Staff Recommendation filed August 7, 2008, in this docket, based on the following assumptions, inserting additional columns as necessary:
 - A. "Per City Gas Petition - Without MidCourse (Option 1)" based on the current PGA cap, actual July data, and the petition's 2008 expected costs and revenue for the remainder of the year.
 - B. "Per City Gas Petition - With Midcourse (Option 2)" based on FCG's proposed PGA cap for October through December, actual July data rather than forecasted data, and the petition's expected costs for the remainder of the 2008 year.
 - C. "Per City Gas Petition - With Half of Requested Midcourse (Option 3)" based upon a presumed PGA cap of \$1.3175/therm for October through December, actual July data rather than forecasted data, and the petition's expected costs for the remainder of the 2008 year.
 - D. "Per Recent Market Data - Without Midcourse (Option 1)" based on the current PGA cap, actual July data, and projected cost data based on latest NYMEX forward curve for the remainder of 2008.
 - E. "Per Recent Market Data - With Midcourse (Option 2)" based on FCG's proposed PGA cap for October through December, actual July data, and projected cost data based on latest NYMEX forward curve for the remainder of 2008.


