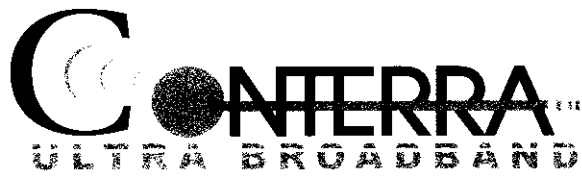

ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated July 1, 2008, Conterra, LLC d/b/a Conterra Wireless Broadband, holder of Alternative Access Vendor Certificate of Public Convenience and Necessity No. 8536, requested that Certificate No. 8536 be amended to reflect the new corporate name, Conterra Ultra Broadband, LLC. Upon review of the Department of State, Division of Corporations' records, it appears that Conterra, LLC d/b/a Conterra Wireless Broadband has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 8536 to reflect the new corporate name.

This Order will serve as the amended Alternative Access Vendor Certificate of Public Convenience and Necessity No. 8536 for Conterra Ultra Broadband, LLC. Conterra Ultra Broadband, LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Conterra, LLC d/b/a Conterra Wireless Broadband to change the name on Certificate No. 8536 from Conterra, LLC d/b/a Conterra Wireless Broadband to Conterra Ultra Broadband, LLC is hereby approved. It is further
