





NOTICE OF RATE DECREASE

GOLD COAST UTILITY CORP.

ISSUED: September 9, 2008

The Florida Public Service Commission (the "Commission") approved the current rates of Gold Coast Utility Corp. (the "Utility") by Order No. PSC-07-0609-PAA-WS, issued July 30, 2007 in Docket No. 060246-WS. That Order stated that the Commission would revisit the Utility's approved rates if the Commission altered Rule 25-30.4325, Florida Administrative Code ("F.A.C."), which defines how used and useful plant is calculated in the Utility's revenue requirement. The Commission altered that formula in Docket No. 070183-WS by Order No. PSC-08-0328-FOF-WS, issued May 20, 2008. As such, the Utility's rates have been recalculated and reduced pursuant to Rule 25-30.4325.

The decreased rates and charges approved by the Commission are effective for service on or after September 14, 2008. Schedules showing the current rates and the new Commission-approved rates are attached to this notice.
