Pursuant to this Amendment (the "Amendment"), BellSouth Telecommunications, Inc. d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina and AT&T Tennessee ("AT&T") and TeleDias Communications, Inc. ("TeleDias"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Resale Agreement between the Parties dated November 25, 2007 ("Agreement") to be effective the date of the last signature.

WHEREAS, AT&T and TeleDias entered into the Agreement on November 25, 2007, and;

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree to replace the initial Section in the General Terms and Conditions and replace with the following language:

WHEREAS, TeleDias is or seeks to become a CLEC authorized to provide telecommunications services in the states of Georgia and Florida.

- 2. The Parties agree that <u>AT&T-9STATE</u> shall be defined as the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
- 3. The Parties agree to add Rates contained in Attachment 1, Resale Discounts & Rates as Exhibit 1 attached hereto and incorporated herein by this reference.
- This Amendment shall be effective the date of the last signature executing the Amendment.
- All of the other provisions of the Resale Agreement, dated November 25, 2007, shall Remain in full force and effect.
