FiberLight, LLC ("FiberLight"), by its attorneys and pursuant to Rule 25-22.006(4), Florida Administrative Code, hereby requests confidential treatment of an exhibit attached to its Application Form for Authority to Provide Competitive Local Exchange Telecommunications Company Service Within the State of Florida ("Application"). Specifically, FiberLight requests confidential treatment of Exhibit C which contains proprietary FiberLight financial statements ("Financial Statements").

FiberLight is a privately-held limited liability company and its ownership, operations, finances and business plans are not matters of public record. Because FiberLight's Financial Statements contain confidential and commercially-sensitive information from which its competitors may derive economic value, FiberLight actively seeks to protect such material from public disclosure. FiberLight ordinarily does not disclose information about its finances and internal business operations and requires all of its employees, agents and contractors to maintain the confidentiality of this information.

FiberLight derives independent economic value from the fact that significant, detailed and proprietary information regarding the Company's financial structure and current financing activities is unknown to its competitors. FiberLight seeks to operate in the State of Florida as a provider of competitive local exchange telecommunications services, a highly



If any person or entity requests disclosure of FiberLight's *Exhibit C*, please notify counsel for FiberLight immediately in order to permit it to oppose such request or take such other action to safeguard its interests as it deems necessary.
