SJNG's Position: \$0.23379 cents for RS-1, \$0.11902 cents for RS-2, \$.08797 cents for RS-3, \$.08792 cents for GS-1, \$.04075 cents for GS-2, \$.01566 cents for FTS-4, and \$0.0380 cents for FTS-5.
