

St. Joe Natural Gas Company, Inc. ("SJNG") by and through its undersigned officer, hereby submits its Revised Prehearing Statements for the hearing scheduled to commence in the proceeding November 6, 2008.

C. Statement of Basic Position:

The Commission should approve the final adjusted net true-up amount for the twelve month period ending December 31, 2008 including interest, the projected conservation program expenses for the twelve month period ending Dec 31, 2009 and the Conservation Cost Recovery Factors to be applied to customer bills rendered for the twelve month period ending December 31, 2009 as filed by SJNG.

D. SJNG's position on each issue:

1. What are the final conservation cost recovery true-up amounts for the period January 2007 through December 2007?

SJNG: An underrecovery of \$63,204.00

2. What are the actual/estimated conservation cost recovery true-up amounts for the period January 2008 through December 2008?

SJNG: An underrecovery of \$78,728.00.

3. What are the total conservation cost recovery amounts to be collected during the period January 2009 through December 2009?


SJNG: An underrecovery of \$125,428.

4. What is the appropriate Conservation Cost Recovery Factor to be applied to customer bills during the twelve month period ending December 31, 2009?

SJNG: \$0.23379 per therm for RS-1, \$0.11902 per therm for RS-2, \$.08797 per therm for RS-3, \$.08792 per therm for GS-1, \$.04075 per therm for GS-2, \$.01566 per therm for FTS-4, and \$0.00380 per therm for FTS-5.

5. What should be the effective date of the new conservation cost recovery factors for billing purposes?

SJNG: The effective date should be January 1, 2009.
