1. Please provide revised MFR schedules incorporating the audit findings from Staff's audit reports dated August 22, 2008 and September 18, 2008 that the company is in agreement with. Please provide all supporting calculations with the revised MFR schedules.
2. Please explain why the company reports no increases on Schedule A-12, Schedule of Contributions in Aid of Construction, pages 3 of 4 and 4 of 4, even though the company is forecasting additions to plant in service for 2007, 2008 and 2009 for both water and wastewater.


