Notice is hereby given on the 12th day of August, 2008 pursuant to Section 367.045, Florida Statutes and section 25-30.030 of the Florida Administrative Code, of the Application of Aqua Utilities Florida, Inc., 1100 Thomas Avenue, Leesburg, Florida 34748, of its intent to apply to the Florida Public Service Commission to extend its service area to provide water and wastewater service to the property described below in Pasco County Florida.

LEGAL DESCRIPTION:

Jasmine Lakes Revised Legal Description

Township 25 South, Range 16 East, Pasco County, Florida.

Section 14:

Begin at the Southwest corner of Section 14 and run 2637.9 feet North 0°6'29"West, thence run South 89°38'24"East a distance of 955.5 feet to a point located on the Northern right-of-way line of Jasmine Boulevard, thence meander Southwesterly 376.1 feet along said right-of-way line, thence run South 2°59'49"West a distance of 2507.9 feet, thence run North 89°48'11"West a distance of 472.5 feet to the Point of Beginning.

Section 15:

The East 1/2 of Section 15 less the North 1/4 of the East 1/2, also the South 1/2 of the Northwest 1/4 of Section 15 lying East of State Road 19, and the North 1/2 of the Southwest 1/4 of Section 15.

Section 16:

That portion of the North 1/2 of the Southeast 1/4 of Section 16 lying East of State Road 19 and the portion of the South 1/2 of the Northeast 1/4 of Section 16 lying east of State Road 19.
