**AMENDMENT TO THE AGREEMENT  
BETWEEN  
EASY TELEPHONE  
AND  
BELLSOUTH TELECOMMUNICATIONS, INC.  
d/b/a AT&T FLORIDA**

This Amendment (the "Amendment") amends the Interconnection Agreement by and between Bellsouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida") and Easy Telephone Services Company ("CLEC"). AT&T Florida and CLEC are hereinafter referred to collectively as the "Parties" and individually as a "Party".

**WHEREAS**, AT&T Florida and CLEC are Parties to an Interconnection Agreement under Sections 251 and 252 of the Communications Act of 1934, as amended (the "Act"), approved March 30, 2006 and as subsequently amended (the "Agreement"); and

**NOW, THEREFORE**, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

1. Attachment 2, Exhibit A is amended to add the USOC "UREPN" which is Bulk Migration per 2-Wire UCL-ND and USOC, "UREPM" which is Bulk Migration Order Coordination, per 2 Wire UCL-ND. The rates for these USOCs will be as set forth in Attachment 2, Exhibit A1 of this amendment.
2. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
3. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remedies thereof.
4. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement.
5. The Amendment Effective Date shall be thirty calendar days after execution of this amendment by both Parties.




