Dear Richard:

In response to Staff's queries regarding the addition of the Saddlebag Lake Owner's Association ("SLOA") parcel to Gold Coast's service territory, I am enclosing maps of the water and wastewater systems currently controlled by SLOA. This is the extent of the maps that SLOA is able to provide to us.

Staff has also requested information regarding the value of SLOA's water and wastewater systems. According to the SLOA, the water and wastewater systems were built in 1973 and are both fully depreciated. However, the wastewater system had \$1.38 million worth of rehabilitation work done to the collection system, lines and manhole covers in June of 2006. This original cost less depreciation at the time of transfer will be booked as CIAC. The lines will not be contributed until interconnected, which is another 2-3 years away. Please note that there is no contract between the parties for the transfer of the water and wastewater systems.
