**ORDER DISMISSING CONFIRMED CHAPTER 13
CASE FOR FAILURE TO MAKE PLAN PAYMENTS**

THIS CASE came on for consideration for the purpose of entering an appropriate Order in this case. The Court, having reviewed the record, finds that an Order on Trustee's Motion To Dismiss For Failure to Make Payments to the Trustee and Granting Period to Cure Default was entered on January 31, 2007 for reason of the Debtor's delinquency in payments to the Trustee. The Court has been advised that the Debtor failed to comply with said Order. Therefore, it is,

ORDERED, ADJUDGED AND DECREED as follows:

1. The Trustee's Motion to Dismiss is now hereby GRANTED and this case be and the same is hereby DISMISSED without prejudice.
2. That any party in interest may request the Court to examine the fees paid to the attorney for the Chapter 13 Debtor, by filing a motion to examine attorney's fees within ten (10) days from the date of the entry of this Order.
3. The Trustee shall disburse to creditors any monies not previously disbursed and file his final report and upon filing of same, shall be discharged of his duties as Trustee.

4. The Trustee shall deduct from said monies his normal percentage thereof as necessary costs and expenses from sums collected pursuant to 11 U.S.C. §1326 (a) (2), together with any fee, charge or amount required under 28 U.S.C. §123.

5. The effective date of this Order is delayed 10 days to permit the Debtor to convert this case to another chapter under the Bankruptcy Code if the Debtor wishes to
