**SSC**  Embarq considers the highlighted information confidential because it contains the number of  
**SGA**  residence and business access lines by Retail, Resale and UNE-P. Competitors can use this  
**ADM**  information to gauge market share. In addition, Embarq is required by its Interconnection  
**CLK**  Agreements (ICA) as well as Section 222 of the Communications Act to protect the confidentiality  
of proprietary information of and relating to its wholesale customers.

Embarq understands this information will be protected from public disclosure until returned to the Company. Pursuant to 364.183(4) staff may retain this information for as long as is necessary for the commission to conduct its business.
